Hi Denise,

ACDEH has not evaluated the excavated soil for reuse at another site including residential (but just received a voice mail from Alan Douglas about the soil). In the normal course of site actions, ACDEH would be concerned that the analytical was sufficient for landfill disposal purposes; normally determined by the landfill of choice. With regards to re-use at a potential residential development, provided the soil met or exceed DTSC clean fill testing guidance, including the warning on composite sampling, the re-use of the soil should be acceptable if the documented concentrations meet applicable regulatory goals.
