Kim, I would like to continue having ACC help me coordinate the requirements with ACEH.

After reviewing this letter I didn't see any reference to the ACC 2015 Phase I we commissioned, did ACEH get a copy and review the findings of that report? I wonder if it would alter their request for a work plan and additional investigation?

It's my understanding (based on notes from the prior MidPen project manager while working with Julia Smith) that:

Given that groundwater depth is greater than 50 feet below surface, and given that a recent 2013 ACC targeted Phase II of the area in the vicinity of the UST was conducted and showed no indication of impact from the former UST, ACC does not recommend conducting further Phase II investigations. Instead, recommended steps include:

- 1. Request and receive a Case Closure related to the UST from Alameda County Health Services. We have initiated that request.
- 2. Within 12 months of start of construction, profile the soil in the area of the former gas station to determine any contamination that could impact either worker health or remediation requirements if we are off-hauling the soil
- 3. In consultation with the Oversight Agency (either the Regional Water Quality Control Board or Alameda County Health Services), determine need for soil vapor sampling.

I want to make sure ACEH's guidance is based on complete information including the 2015 ACC Phase I report, I know there's been staff transition with all parties (ACEH, ACC and MidPen) so I'm a little cautious about their request to do further investigation given that ACC did not recommended doing further Phase II investigations. Perhaps it would be prudent to contact Anne Jurek with ACEH anne.jurek@acgov.org (510) 567-6721to make sure we're on the same page.

Also, do you or someone at ACC know about initiating the Case Closure related to the UST from ACEH?

Can we discuss? I'm available anytime tomorrow or Tuesday or Wednesday for a call.
