I've been in communication with Elena Joy at DTSC and we both are in agreement that it makes more sense for ACDEH to continue with the oversight of the Horton Street UST case. I will be copying her with our letters so she has periodic updates as to the progress of the case. That said, I should extend the submittal time for the work plan requested in our October 2015 directive letter (December 18, 2015) due to delays in following up with her. Our standard is about 60 days, so that would place the submittal due date about August 15.

An additional question. I have Nancy Humphrey as my environmental contact for the Emeryville. Due to the location of the former UST, should that change, or should she remain as principal contact for this case? I can additionally copy other interested people with our letters so that progress can be tracked.
