FACT SHEET ON ENVIRONMENTAL REMEDIAL ACTIONS

SUMMARY – This fact sheet has been prepared to inform community members and other interested stakeholders of the proposed approach for development and the associated environmental remedial actions proposed at the CNG Station Project (the "Site") in Oakland, California. Pacific Gas and Electric Company (PG&E), the property owner and lead responsible party (RP) for the case, has submitted a proposed cleanup plan called a Feasibility Study/Remedial Action Plan (FS/RAP) for the proposed Site development. This fact sheet contains information concerning site background, discussion of recent investigations, proposed remedial action plans, planned site redevelopment activities, and project contacts.

The Alameda County Department Environmental Health (ACDEH) invites you to review and comment on the proposed cleanup The draft FS/RAP proposes plan for Site. excavation and off-site disposal of soil contaminated with petroleum hydrocarbons (TPH), volatile organic compounds (VOCs), semi-volatile organic compounds (SVOCs), polychlorinated biphenyl's (PCBs), metals and pesticides. Groundwater would be treated onsite and monitored to confirm the effectiveness of cleanup.

SITE BACKGROUND – The Site, located at 205 Brush Street in Oakland, is about three-quarters of an acre and contains three vacant buildings. The Site was historically used by the Port of Oakland for construction offices, automotive maintenance, vehicle fueling, and warehousing. In addition, two underground storage tanks (USTs) and approximately 126 tons of petroleum contaminated soil were removed from the site in 2003.

Over the next year, PG&E plans to redevelop the Site as a gas regulator station to support the

new gas distribution system being installed along 3rd Street. The on-site buildings would be demolished and construction would include the excavation of trenches to install infrastructure for the gas regulator station. To minimize impacts to the community, remediation work would be conducted concurrently with regulator station construction.

SITE INVESTIGATION FINDINGS – Site investigations have been conducted to determine the extent of impacts to soil, groundwater and soil vapor (the air between particles of soil).

Investigations found that that soil and groundwater contain low levels of petroleum hydrocarbons (TPH), volatile organic compounds (VOCs), and semi-volatile organic compounds (SVOCs) in the southwestern portion of the Site where the USTs were located. In addition, soil from 1 to 4 feet contains metals and low concentrations of polychlorinated biphenyls (PCBs) and pesticides.

Groundwater impacts are primarily found in the location of the former USTs. As the contaminant

plume has not been delineated, it will be evaluated in future investigations. Soil vapor samples indicate the presence of VOCs in the vicinity of the former automotive maintenance area

PROPOSED CLEANUP PLAN– PG&E, under the oversight of ACDEH, prepared a Feasibility Study/Remedial Action Plan (FS/RAP) which evaluates cleanup options and recommends the following:

- Soil Excavation/Off-Site Disposal –
 Approximately 4,500 tons of soil would be excavated. Contaminated soil would be disposed of at a licensed facility and excavated areas would be backfilled with clean material.
- Groundwater Treatment and Monitoring – Groundwater would be treated using a process called chemical oxidation. Oxidants are injected into groundwater wells causing a chemical reaction that destroys contaminants and produces harmless byproducts. Groundwater would continue to be monitored to make sure levels of chemicals are declining.
- Land Use Covenant A land use covenant would be recorded for the Site to document Site conditions, ensure the proper management of soil, and limit groundwater uses.

HEALTH AND SAFETY - All work would be conducted in accordance with a Site-specific Health and Safety Plan and overseen by the ACDEH.

redevelopment activities and should take 12 months. During Site redevelopment, increased construction traffic and noise from activities at the site are expected. Dust generation during earthwork will be rigorously monitored and actively suppressed using water, tarps and other measures to minimize dust. Truck tires and undercarriages would be cleaned before trucks leave the Site. Equipment noise is anticipated to be moderate.

NEXT STEPS – PG&E is working with ACDEH to conduct soil investigations to further assess subsurface conditions prior to the start-up of excavation activities.
