Hi Dilan.

In preparation for our upcoming meeting on November 10, I have attached revised text figures as well as other items you requested in our last call. Below is a summary of the action items/revisions requested in our last call and measures to address each item:

- 1. Upload SMP report onto ACEH's FTP site This was done immediately following the 10/13 call. I contacted Anne Jurek and she verified that the file was present on their server.
- 2. Send ACEH a Word doc of fact sheet This was emailed to Dilan and Anne on 10/13. Anne reviewed and had no changes, but Anne mention that Dilan may have comments.
- 3. Provide ACEH a copy of building permit plan with cover page. The cover page for the plans does indicate proof of submittal, therefore I have attached the receipt provided by the Building Department.
- 4. Include plan showing that vapor barrier is incorporated into construction drawings submitted to the Building Department. See attached sheets from plans submitted to the Building Department.
- 5. Include CQA for vapor barrier installation. See revised draft text in the SMP and attached construction spec which includes installation QA/QC protocols. Note that the vapor barrier product has changed since our last submittal. The text has been revised to reflect this and new vapor barrier product info attached.
- 6. Include ongoing monitoring and maintenance plan for vapor barrier system **Added text describing maintenance protocols.**
- 7. Include specs on Stego wrap. Stego wrap is not part of the contaminant vapor barrier; it will be used elsewhere on site as a moisture barrier and is not pertinent to the SMP; the waterproofing/ contaminant barrier is made up of a different type of membrane with pre-applied spray on product
- 8. Include the imported fill will be subject to DTSC clean fill guidelines Added language to text
- 9. Add volume information of excavated material Added language to text
- 10. Include confirmation sample points on plan Added confirmation points to Figure 8 see attached
- 11. Discuss decontamination method of trucks if contaminated Added equipment and vehicle decontamination language to text
- 12. Discuss preferential pathway of plume once new utilities/structures are added. Added discussion to text

All report text changes are highlighted in yellow in the attached version.
