Map of the Academy Homestead. (Bk. 22 Deeds Pg. 639)

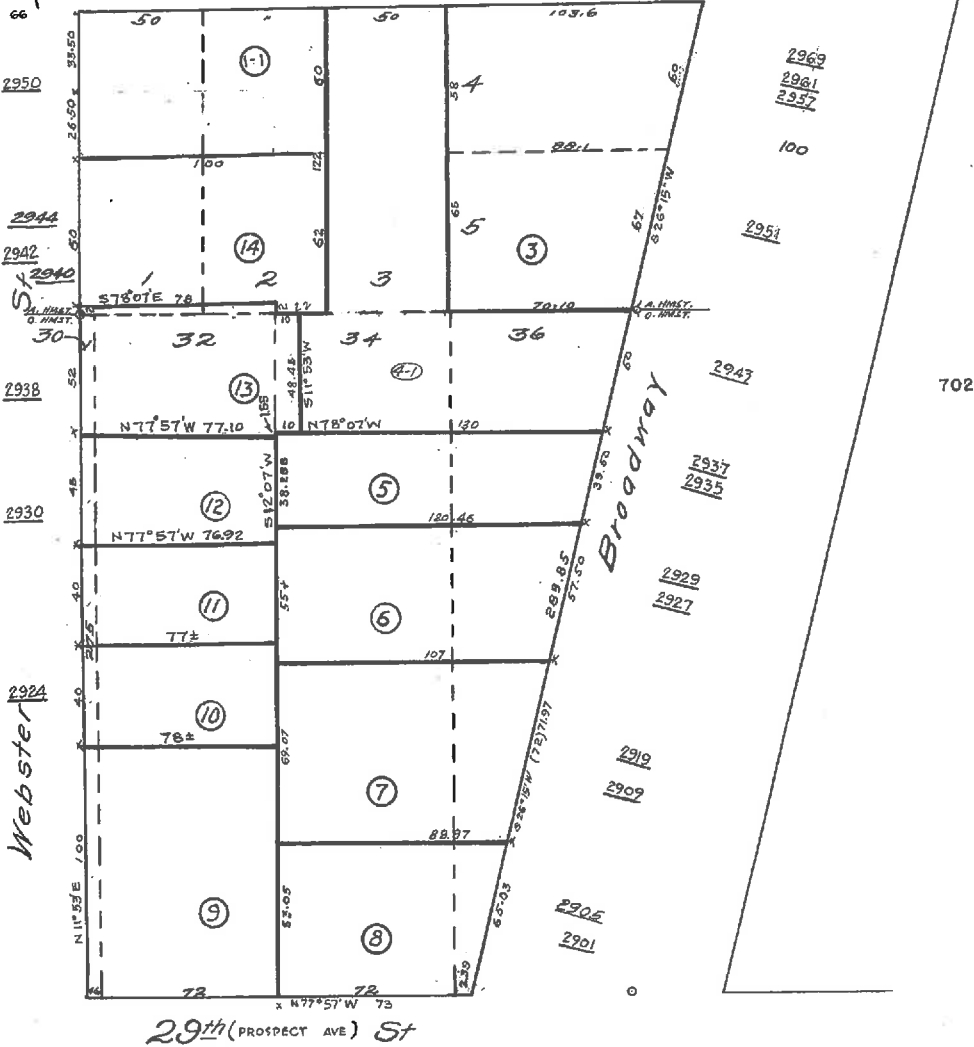
