- Upload EDFs for the August 2016 sampling
- Upload missing phase I and phase II report, as well as the project schedule and tentative map/site plan
- Add shading to show various features of proposed development
- Prepare a figure showing fill depth and cross-sections
- Prepare and submit workplan:
 - 1) collect grab groundwater samples (including measurement of depth of water) and analyze for TPH-g/VOCs (including naphthalene), TPH-d/mo, and CAM-17 metals
 - 2) Collect soil samples within the 0-5 feet zone and at approximately 8 feet in a grid, and analyze for TOH-g/VOCs (including BTEX and naphthalene) and TPH-d/mo

- Prepare and submit a Remedial Action Plan (RAP) describing excavation of arsenic/pesticide-impacted soil and secondary source removal.
- Prepare and submit a Remedial Action Implementation Plan (RAIP) describing activities for implementation of RAP
