Good Morning Joshua:

I have reviewed the work plan and request that in addition to tagging the water levels in the groundwater monitoring wells that you also collect groundwater samples and analyze for TPH compounds and volatile organic compounds.

Also given that the 3007 Brook Street property is vacant (I believe when we spoke last month the status of the occupancy of this site was uncertain?) I would like to revisit the rationale for not collecting soil and groundwater samples on this parcel in the vicinity of the sewer and floor drains on 260 30th Street parcel.

I am reviewing the work plan at home this morning and do not have access to the case file and don't recall the specifics of the redevelopment project. Can you please remind me of the extents of the subterranean garage and tell me the depth of the construction excavation at the 3007 Brooke Street parcel and the 250 30th Street parcel. I believe the subterranean garage extends beneath the entire redevelopment but want to verify this.
