This provides written notice that Alameda County Department of Environmental Health has received a request and intends to enter into a Voluntary Remedial Action Agreement with the responsible party pursuant to Health and Safety Code Section 101480 in approximately 10 working days.

The following information is provided:

- (a) The name and address of the Responsible Party is Haig's Delicacies, LLC, 25673 Nickel Place, Hayward, CA 94545
- (b) The name and address of the site owner is the Rita Takvorian Trust, 25673 Nickel Place, Hayward, CA 94545
- (c) The Voluntary Remedial Action Agreement will apply to 25673 Nickel Place, Hayward, CA 94545
- (d) The purpose of the Remedial Action Agreement will be to investigate the extent of soil, groundwater, and soil vapor contamination which include chlorinated solvents and petroleum hydrocarbons as a result of historical storage and potential release(s) from past uses at the site by previous tenants.
