Good afternoon Mark,

I have attached the permit (**W2019-0062**) from AC Public works for **12 borings**. We had obtained this permit for 2200 Telegraph Ave, back in February 2018, with an intention of completing all hand auger borings and direct push borings at the same time.

However, at that time we could complete only **7 borings** @ 2200 Telegraph (DPT-5 and B-1 through B6). Due to BART permitting process, the **(5) hand auger borings** in the BART right-of-way (B-7 through B-11) got delayed. So I requested **Mr. Eneyew Amberber** from AC Public works to give us an **extension** on the permit and he gave us **until April 30, 2018**.

Now we have received an authorization/permit from BART as well. Hence, we are scheduling this work now. I have already notified Mr. Amberber of the upcoming field work on Friday, April 27, 2018.
