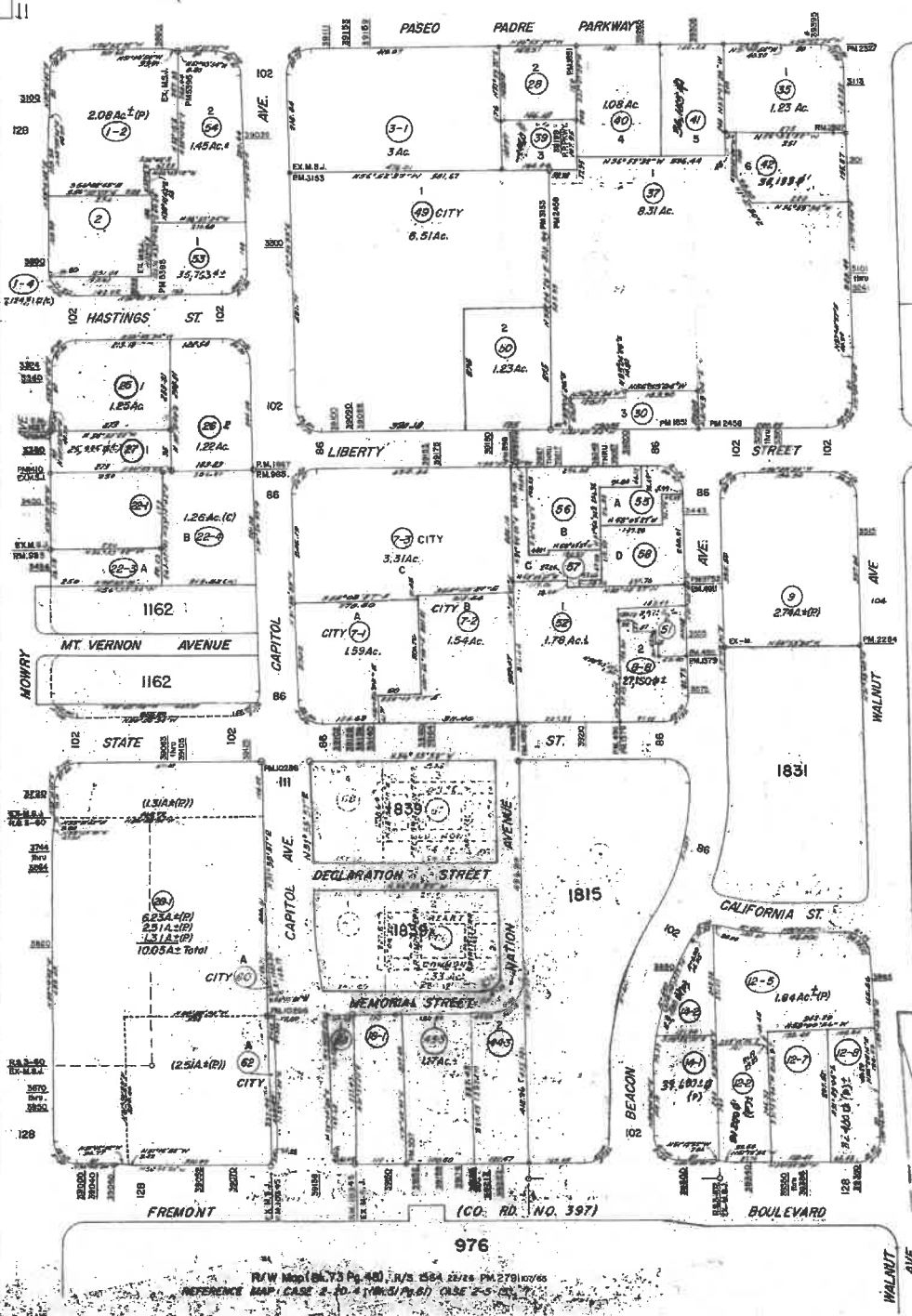
MAP OF TRACT KNOWN AS EX-MISSION SAN JOSE (Case 1-6-15)
